- Air quality is deteriorating significantly.
- Poor air quality affects growing lungs.
- Air pollution causes increased respiratory illnesses in both children and adults.
- Air pollution has been calculated to cause 1,600 avoidable deaths per year.
- Air pollution has contributed to up to 64,000 avoidable hospital bed days per year secondary to cardiac and respiratory illnesses.
- Direct costs (health care, loss of productivity and intangibles) secondary to poor air quality resulting in illness and death is estimated at HK\$19 billion (health care: HK\$1 1.5 billion; loss of productivity: HK\$0.3-0.5 billion; intangibles: HK\$19 billion).
- Poor air quality has a significant impact on local quality of life.
- Poor air quality has already had a significant impact on the local economy.

 use internationally accepted standards of measurement of air quality;

• address the significance of the negative impact to health caused by poor air quality;

• provide effective and informed communication to the community based on information derived from the AQO.

The air quality in Hong Kong is now of political, economic and social significance. The review of AQO should be part and parcel of the overall development of an action plan, both short term and long term, to improve air quality. Control measures like promotion of emission reduction and an effective transport policy, collaboration with neighbouring authorities to negotiate and reduce emission, etc should be considered and introduced as soon as possible. Last but not the least is the enhancement of ongoing and relevant research in this area to support the development of evidence based and socially accepted policy.
