

Western District Health Service DIRECTOR OF MEDICAL SERVICES

Western District Health Service is the main referral centre for the Southern Grampians/Glenelg area and has close affiliations with Greater Health, Flinders, and Deakin Universities.

Western District Health Service is a fully accredited multi-campus Health Service, which includes Hamilton Base Hospital, Penshurst District Health Service, Coleraine District Health Service and Frances Hewett Community Centre.

The main Hamilton Base Hospital campus has 75 acute beds, 90 aged care beds and a range of community based services, with 7000 admissions and 210 deliveries per year. The hospital performs 3000 surgical procedures per year and has ICU and HDU facilities. In addition to the above there are four Physicians, three Surgeons and a Consultant Anaesthetist resident in Hamilton. Visiting services include orthopaedics, ENT, ophthalmology, urology, dermatology, endocrinology and neurology. Western District Health Service also provides services to all surrounding health services.

Due to the pending retirement of the present incumbent, Western District Health Service is seeking to appoint a suitably qualified and dynamic Medical Administrator to its Executive team to provide clinical leadership in partnership with other Executive team members in the planning and delivery of high quality and efficient services to the community.

Hamilton is 3½ hours by car from Melbourne and 5½ hours by car from Adelaide. Being located in the Greater Green Triangle of Victoria, it is within easy distance of the Grampians, Coonawarra wine region and the coastal resorts of Warrnambool, Port Fairy and Portland. Hamilton is renowned for its educational facilities, both private and public, at both primary and secondary level. Deakin University has a campus at Warrnambool and RMIT University has a campus at Hamilton.

The successful applicant must be eligible for recognition with the Medical Practitioners Board of Victoria and hold a current drivers licence. Appointment will be subject to a satisfactory police check.
